Business challenge

The purchase of VMware by Broadcom and their launch of new simplified tiered products is forcing organisations to evaluate their VMware estate and options. The new options from Broadcom often result in higher costs for businesses (Insight estimates this increase can vary from 1.5x to 4x, depending on the combination of old licenses in use). These new offerings include many VMware features bundled as standard which were not included when buying perpetual licenses individually.

The impact of this change to clients is being seen as follows:

- Previously licenses could be purchased individually as perpetual licenses. This is no longer an option for clients wanting to renew or add additional licenses.
- The new Broadcom licenses are bundled into 3 main offerings:
 - VMware vSphere Standard
 - VMware vSphere Foundation
 - VMware Cloud Foundation
- These offerings are subscription only, for 1, 3 or 5 years.
- VMware vSphere Standard includes vSphere standard and vCentre server standard.
- VMware vSphere Foundation includes vSAN, Kubernetes and Aria operations as well as vSphere and vCenter licensing.

- VMware Cloud Foundation includes the contents of vSphere Foundation as well as NSX and SDDC.
- Add-ons are available for the Foundation packages, including vSAN capacity, SRM and other feature upgrades.
- Customers with perpetual licenses will see their costs increase when their support contract ends.
- To continue receiving support they will need to move to one of the new subscription offerings.
- Service provider clients existing VCPP agreements will end on 30 April 2024. Only subscription VMware Cloud Foundation licenses can be used after that, VCPP clients may see price increases of 2x or above.

These changes have prompted organisations to review their VMware licensing landscape and assess their alternatives in light of the expected renewal costs. Businesses are looking for guidance from reliable partners with a wide market perspective to understand how these changes will impact their future direction and what options are available if they decide to switch from VMware.
